2. juulil 2024 toimus Tallinnas, Eestis, Baltic Horizon Fondi osakuomanike ja Rootsi hoidmistunnistuse omanike erakorraline üldkoosolek.

Koosoleku päevakord oli alljärgnev:

1. Uute Baltic Horizon Fondi osakute väljaandmine suunatud pakkumise teel aastal 2024 Baltic Horizon Fondi bilansi tugevdamiseks.

Koosolekule registreerunud osakuomanikele kuulus 16,242,768 osakut, mis esindavad vähem kui 14% kogu häälte arvust, mistöttu ei olnud koosolek pädev otsuseid vastu võtma. Osakuomanikud ei saanud vastu võtta päevakorras olnud otsust.

Fondivalitseja otsustab korduskoosoleku kokkukutsumise kahe nädala jooksul.
