

<p>Tallinn, 18. juuli 2008</p> <p>AS Q Vara Äriregistri kood: 10907184 Address: Mustamäe tee 54, 10621 Tallinn, Eesti</p> <p>Lugupeetud võlakirjainvestor,</p> <p>Omakapitali osakaalu nõude täitmisest.</p> <p>Vastavalt 7. aprillil 2008 lõppenud võlakirjainvestorite hääletuse tulemustele nõustusid Q Vara investorid ettepanekuga anda ettevõttele aega 2008. aasta 30. juunini võlakirjaemissiooni tingimustes nõutud omakapitali osakaalu määra vastavusse viimiseks. Tagamaks tingimuste täitmist andis Q Vara omanik OÜ SLProductions 24. märtsil 2008 kinnituse investeerida vajadusel täiendavat kapitali.</p> <p>Vastavalt 26. juunil 2008 esitatud börsiteatele sõlmisid Q Vara ja OÜ SLProductions tütaretevõtte OÜ Q Capital 25. juunil 2008 laenulepingu, mille kohaselt andis OÜ Q Capital AS'le Q Vara allutatud laenu summas 86 000 000 eesti krooni (laenu on allutatud kõikidele Q Vara kohustustele). Täiendavat kapitali kasutatakse olemasolevate kohustuste tasumiseks ning likviidsuspuhvri tekitamiseks. Kohe peale laenulepingu allkirjastamist alustati allutatud laenu omakapitaliks konverteerimist. Nimetatud protsessiga on kavas jõuda lõpule hiljemalt käesoleva aasta augusti lõpuks.</p> <p>Peale omanike täiendavat investeeringut on täidetud võlakirjaemissiooni tingimustega nõutud Q Vara omakapitali osakaalu nõue ning Q Vara omakapitali osakaal ettevõtte koguvaradest ületab 30%. Q Vara bilanss ja kasumiaruanne juuni lõpu seisuga esitatakse investoritele börsi infosüsteemi kaudu hiljemalt 31. juuliks 2008.</p> <p>Eesmärgiga kindlustada Q Vara positsioone, on lisaks omakapitali suurendamisele töös järgmised suuremahulised tehingud:</p> <p><u>Terminal Nr. 11 (Eesti)</u> Läbirääkimised potentsiaalsete kaasinvestoritega jätkuvad. Tulenevalt väga põhjalikust analüüsist on projekti ettevalmistus nõudnud esialgsest pikemat aega. In order to grant required equity level in Q Vara, OÜ SLProductions, shareholder of Q Vara, issued an assurance letter on March 24, 2008 according to which it confirmed its readiness to invest additional capital into Q Vara if needed.</p> <p>According to announcement issued on June 26, 2008 Q Vara signed a loan agreement with OÜ SLProductions' subsidiary OÜ Q Capital according to which OÜ Q Capital gave to Q Vara 86 000 000 EEK of subordinated loan (the loan is subordinated to all other Q Vara liabilities). The additional capital will be used to pay off the current liabilities and creating a liquidity buffer. Process to convert the subordinated loan into owners' capital was initiated just after the signing of the loan contract. The mentioned process is expected to be finished by the end of August 2008.</p> <p>After the additional investment from shareholders Q Vara has fulfilled its equity share requirement and its equity exceed 30% of its balance sheet volume. Q Vara will disclose its 6 month 2008 balance sheet and profit/loss statement by July 31, 2008 at the latest.</p> <p>In order to improve position of Q Vara other large scale projects in process in addition to own capital increase are:</p> <p><u>Terminal No. 11 (Estonia)</u> Negotiations with potential co-investors are going on. Preparation of project has required longer period as initially planned due to very detailed analysis. According to today's knowledge this deal is planned to close in August-September current year.</p> <p><u>Maskavas (Latvia)</u> Sales process of Maskavas is going according to prognosed schedule and by all estimations will be end in September-November current year.</p> <p>After the completion of Terminal No. 11 and Maskavas deals prognosed owner' equity share in</p>
